




Introduction:

N. L. Dalmia College of Arts, Commerce & Science ("the College") has been established by the Niranjanlal Dalmia Educational Society (NLDES) which operates two centres of excellence in education, namely Niranjanlal Dalmia High School founded in 1991 and Niranjanlal Dalmia Institute of Management Studies & Research in 1995. The College aims to maintain the same commendable quality standards of education set by these two centres of excellence.

The NLDES received permission from the State Government in 2018-19 to setup a new Degree College affiliated to the University of Mumbai. The College offers courses in subjects that enhance the employability of students, offer wide range of career opportunities, open up avenues for entrepreneurship and increase the students competency for competitive examinations.

In future, the NLDES aims for the natural progression of the Degree College to the postgraduate and doctoral levels with emphasis on research in basic and applied areas; subject to permission from statutory bodies.

Admission Guidelines:

Parents and students are requested to go through the prospectus, admission notices and circulars put on the University of Mumbai website (www.mum.digitaluniversity.ac) and College notice boards before seeking admission in the College.

The Principal reserves the right to amend or modify the rules regarding admission, if and when any amendments/ revised guidelines are received from the University, Government or the Management. The Principal also reserves the right to refuse admission, if in his/her opinion, such an admission is likely to adversely affect the overall discipline of the College.

Admission preference will be given to students who have fulfilled the eligibility qualification criteria in the preceding academic year, and also to the inhouse students who have passed Std XII (ISC) exam from N. L. Dalmia High School.

First Year Admissions

Admission process for FYBA, FYBSc, FYBCom and FYBMS Courses as follows:

- 1. All the admissions are online and as per the University schedule given on the University website.
- 2. The students should visit the University Website (www.mu.ac.in or www.mum.digitaluniversity.ac) open the link "Admissions" or "Admissions to FY Courses" to display the Pre-admission Enrollment Form, fill in the required details of Courses and take the printout. This step is mandatory.
- 3. With the printout of the Pre-admission Enrollment Form, the student should report to the College Accounts Office, pay ₹ 100/- in cash and receive the College Admission Form and the College Prospectus.
- 4. The students are required to fill in the College Admission Form and select the subjects or group of subjects as per their choice; the details of which are given in the College Prospectus. Students must affix 2 (Two) photographs on the College Admission Form in the boxes provided.
- 5. The students must apply separately for each course, if he/she desires.
- 6. Pre-admission: The student must submit the following in the College Office
 - (a) Duly filled in printout of the Pre-admission Enrollment Form downloaded from the University Website; and
 - (b) Duly filled in College Admission Form. He/she will receive token/receipt, which will be required for confirming his/her Admission after the Merit List.

- 7. The merit list will be put up and displayed by the College as per the University of Mumbai schedule.
- 8. Admission Confirmation: If a student's name appears in the College merit list, then he/she must immediately contact the College office to confirm the admission. For this, he/she must carry-
 - (a) Admission Token / Receipt;
 - (b) Original documents with the required number of photocopies; and
 - (c) The Demand Draft favouring "N. L. Dalmia College" for the required amount of fees; details of which are given in the College Prospectus. (Page No. 25)

- 9. On verification by the Admission Committee, the student should pay the required amount of fees in the Accounts Office and receive the Fee Receipt as the confirmation of admission. The original Fee Receipt must be carefully preserved.
- 10. If the student fails to confirm his/her admission as stated above, his/her name will not be considered in the subsequent merit lists.

Important: All admissions are provisional and done strictly on merit basis. The admission is confirmed on the basis of submission of original documents, scrutiny and approval of Admission Committee and payment of full amount of fee. The College has no Management Quota, and charges no Donation and no Capitation Fee for admission.

Note: The Admission Forms for FY Courses in N. L. Dalmia College of Arts, Commerce & Science and the Prospectus are also available on the College Website (www.nldalmia.co) for reference. Hard copy of the same will be issued at pre-admission.

- Original Junior College Leaving Certificate with 3 (Three) self-attested photocopies
- One self-attested photocopy each, of the Std X Marksheet and Passing Certificate
- Provisional Eligibility Certificate (Applicable for students from other than Maharashtra State Board)
- Migration Certificate (Applicable for students from other than Maharashtra State Board)
- One self-attested photocopy each, of Aadhaar Card and PAN Card
- Two passport size photographs of the student (Frontal view of the full face against white background)
- GAP Certificate (Joint Affidavit) of the student and either of the parents on a ₹100/-stamp paper, if there is a break of more than a year in the academic career after passing Std XII (Draft of GAP Certificate will be provided).

- 2. The number of seats for different subjects and elective combinations will be decided by the Principal.
- 3. Subject(s) and elective(s), which do not have the minimum enrollment required by the Government/University, will not be offered.
- 4. Examinations of Sem I, II, III and IV will be conducted by the College on behalf of the University of Mumbai as per the University schedule, rules, regulations and guidelines, while examinations of Sem V & VI will be conducted by the University.

A candidate being eligible for admission to the three years degree programme leading to the degree of Bachelor of Arts (BA) must have passed the Higher Secondary School Certificate examination (Std XII) conducted by the State Board of Secondary and Higher Secondary Education, in the following subjects:

- 1. English (Higher or Lower level) carrying 100 marks
- 2. Any one of the modern Indian languages or modern foreign languages or any classical language (Higher or Lower level) carrying 100 marks
- 3. Four other subjects from among the subjects mentioned below carrying a total of 400 marks

OR

Three other subjects from among the subjects mentioned below carrying a total of 300 marks and one more subject remaining optional subjects carrying 100 marks as prescribed for the HSC (Std XII) examination.

OR

Must have passed an Examination of another University or Body or Board recognized as equivalent to the HSC (Std XII) examination conducted by the Maharashtra State Board of the Secondary & Higher Secondary Education.

EXAMINATION SCHEME:

- 1. Credit Based Semester and Grading System (CBSGS) has been introduced for FY, SY and TY Classes in UG programmes.
 - a. As per the new system the examination in each paper (theory and practical) have two components. 25 per cent marks for internal assessment and 75 per cent marks for semester-end examination. Internal assessment in theory is of 25 marks and consists of class test and overall performance of the learner.
 - b. The semester-end examination is of 2½ hours duration for 75 marks. For some courses, each examination theory paper will carry 100 marks at semester-end examination and will have no internal assessment and theory paper will be of 3 hours duration
- 2. Passing Standard for each course/paper there is minimum passing for internal assessment as 40% (10 out of 25 marks), for semester end examination 40% (30 out of 75 marks) & Total 40% (40 out of 100 marks.) A learner will be said to have passed the course if he/she passes the internal assessment and the semester-end examination separately with the aggregate total of both being minimum 40 marks. Whenever practicals are prescribed, minimum 40% of the marks are required to be scored for passing in each head of practicals. Wherever theory paper carries 100 marks, minimum 40% of the marks (40 marks out of 100) are required to be scored for passing in each head of theory paper, which is of 3 hours duration.

ATKT RULES:

From Sem I to Sem II

Eligible for admission to Sem II irrespective of the number of heads of failure in the Semester I.

2. From FY to SY (Sem III)

Eligible for admission to Sem III with not more than 2 (Two) ATKTs in each of the Semester I and Semester II and the total number of ATKTs not exceeding 4 (Four).

3. From Sem III to Sem IV

Eligible for admission to Sem IV irrespective of the number of heads of failure in the Semester III.

4. From SY to TY (Sem V)

Eligible for admission to Sem V with not more than 2 (Two) ATKTs in each of the Semesters III and IV and the total number of ATKTs not exceeding 4 (Four) (No ATKTs from Sem I & Sem II).

5. From Sem V to Sem VI

Eligible for admission to Sem VI irrespective of the number of heads of failure in the Semester V, however all the previous ATKTs from Sem I to Sem IV must have been cleared to be eligible for appearing at the University Sem VI Examinations.

RESULTS:

Results will be declared after every semester in November and April every year. Students can apply for verification of marks in one or more papers within 7 (Seven) days of the declaration of result by paying ₹ 100/- (Rupees One Hundred only) per answer paper. Verification will be done with respect to:

- Totalling of marks question wise and overall.
- Transfer of marks from paper to mark sheet and final compilation.
- · Question left uncorrected or unassessed, if any.

RE-VALUATION:

As per University Circular No. Exam NCD/College (RefNER) 1603 of 2005, dated September 29, 2005 students are allowed to get photocopies of their answer books by submitting the prescribed application and paying fees of ₹ 100/- (Rupees One Hundred only) per answer book. Students can make such application not later than 1 (One) week of declaration of result. Students will receive a photocopy of answer book(s) after 10 (Ten) days from the date of payment of Re-Valuation Fee.

If they desire, they can apply for re-valuation with the photocopy of answer book through a prescribed form and by paying fees of ₹ 500/- (Rupees Five Hundred only) per paper/answer book.

UNFAIR MEANS: (Ordinance 0.5050)

Students who are reported to indulge in using unfair means during the examinations, will have to face Unfair Means Committee appointed for assessing the cases. The Unfair Means Committee after scrutinizing the evidence and report of Junior and Senior Supervisors and statements of such student, will take decision about the student according to rules set by University of Mumbai.

Fees are charged as per the University Fee Structure.

- Detailed break up of the fees will be indicated in the Fee Receipt.
- Laboratory/Library/Caution Money deposits are refundable within 6 months after leaving the College against production of the original Fee Receipt(s).
- Fees are likely to be revised by the University of Mumbai/State Government in the subsequent academic year(s).
- The difference due upon upward revision of fees by the University of Mumbai/State Government during the given academic year, will have to be paid immediately.
- Fees for ATKT examinations will have to be paid separately depending on the number of subjects involved.
- Fees must be paid by Demand Draft (DD) only, drawn in the name of "N. L. Dalmia College" on a Nationalized/ Scheduled Bank, payable at Mumbai.
- Students belonging to the reserved and economically backward categories are eligible to receive Scholarships/ Freeships as advised by the Social Welfare Department of the Government of Maharashtra from time to time.
- Fees for Bonafide Certificate, Transfer Certificate, Transcripts and Document Verification will be extra as per University Norms.

MODE OF REFUND OF FEES:

The candidates who take admission in under-graduate programmes may request for refund of the fees after applying in writing for cancellation of their admission to the programme. The refund of fees as applicable shall be made within 30 (Thirty) days after date of cancellation and thereafter. The percentage of fees for the programme shall be refunded to the candidate after deducting charges as follows.

Note: The total amount considered for the refund of fees from the commencement of academic term of the programmes includes the following.

- 1. All the fee items chargeable for one year are as per relevant University Circulars for different faculties (Excluding the programmes for which the total amount fixed by other competent authorities).
- The fee charges towards group insurance and all fee components to be paid as University share are non-refundable, if payment is made by the College prior to the date of cancellation.
- 3. Fees collected for identity card, library card, admission form, prospectus and enrollment are non-refundable after the commencement of the academic term.
- 4. All refundable deposits (Laboratory, Caution Money, Library etc.) shall be fully refunded at the time of cancellation.
- 5. While applying for the refund of fees, the 'Original Fee Receipt' must be attached to the application, otherwise the claim for refund of fees will be rejected.
- 6. The refund of fees will be paid by NEFT directly to the Bank Account of the student who is cancelling his/her admission.

ATTENDANCE RULES: (Ordinance 0.6086)

According to University Circular No. UG/01 of 2014 dated May 5, 2014 and Ordinance 0.6086 of the University for granting the terms in each subject, the minimum attendance of 75% of the theory lectures, practicals and tutorials (taken together) will be required out of the total number of lectures, practicals and tutorials in each subject conducted in the term. Therefore, if the student fails to achieve the required attendance, his/her examination form will not be accepted /or forwarded to the University for Annual or Semend Examination.

To keep a term at a College, the learner must complete to the satisfaction of the Principal, the course of study at the College prescribed for such terms for the class to which such

FACILITIES, COMMITTEES AND ASSOCIATIONS:

LIBRARY: The College Library has a spacious and well-ventilated reading room. It has a rich collection of books on various subjects, which is continuously updated. The working hours of the Library are from 8.00 am to 5.00 pm on all working days.

CLASSROOMS: All classrooms are state-of-the-art equipped with LCD projectors and smart boards

SEMINAR HALL: It is designed as a sectional hall depending on the requirement of the event planned. It can accommodate 250 people and is fully air conditioned. The Seminar Hall is a great asset for the institution as we hold all our meetings, workshops and competitions in this vibrant facility.

AUDITORIUM: One of the main highlights of the College infrastructure is our Auditorium. It is fully air conditioned with a seating capacity of 300 people, equipped with an advanced acoustic system. The auditorium features a stage, where all the cultural and educational programmes are showcased.

COLLEGE GYMKHANA: Well-equipped gymkhana for the well-rounded physical health and nurturing of the students.

CCTV: CCTV cameras are installed at various places in the College campus for the safety, security and smooth running of the College activities

COLLEGE CANTEEN: The College infrastructure has a special area designated as a Canteen. It can accommodate 150 students and serves wholesome food in a hygienic environment. The ambience is perfect for the students.

LABORATORIES: The College has well-equipped Computer, Chemistry and Physics labs. The Psychology lab is under construction.

STUDENTS' GRIEVANCE CELL: It has been set up to create a harmonious environment by redressing the grievances of the students concerned with academic and other related matters.

STUDENTS' COUNSELLING CELL: Counselling is done by professionals who look after the welfare of the students by helping them to cope with stress and developing confidence among them to overcome and face highs and lows of the life.

STUDENTS' COUNCIL: It consists of student representatives who look after and promote the productive involvement of the students in the day to day activities of the College.

WOMEN'S DEVELOPMENT CELL: It is a special cell to inculcate self-reliance, courage and confidence in girl students.

PLACEMENT CELL: It is a well-established facility in our Management Institute and has a 100% track record of placement. We will extend the same facility to our graduating students from the Degree/Senior College. We are the first among a few to offer this facility to our students right from the first year of inception of the College.

RULES & REGULATIONS:

- 1. Punctuality and attendance: Students must attend lectures, practicals and tutorials according to the timetables of their respective classes on all days when the College is working. They must appear for all the College examinations (practical and theory). Absence from any of these or unsatisfactory performance will lead to loss of terms and detention. Every student has to complete the course of study prescribed for the examination for which he/she is studying, including tutorials, to the satisfaction of the Principal. A minimum attendance of 75% in each term is required from the student, failing which strict action will be enforced or student may be detained. A student remaining absent for three lectures in a row, will not be allowed in class unless either parent meets the concerned subject teacher/s with an explanation.
- Identity Card: After admission, each student will be given his/her identity card which
 must be worn by the student throughout the stay in the College premises. Entry to the
 College premises, lectures, practicals, College functions or access to the Library,
 College Office, Laboratories, Canteen and Gymkhana is strictly based on a valid
 identity card.
- 3. **Dress Code:** Every student must always be decently and neatly dressed, befitting the academic environment

4. Conduct and discipline:

- Students must not loiter in the corridors when classes are going on.
- Students must read and follow the notices displayed on the notice boards from time to time. Ignorance of any information put up on the notice board will not be accepted.
- If, for any reason, the continuation of a student in the College is in the opinion of the
 Principal, detrimental to the interests or discipline of the College, she/he may
 dismiss such a student from the College without assigning any reason for her/his
 decision which shall be final. Insubordination and unbecoming language or
 misconduct are sufficient reasons for suspension or dismissal of a student.
- Students shall not communicate any information to the press/media about the matters concerning the College administration.
- Students are not permitted to bring outsiders into the College campus without prior permission.
- No society must be formed, no meeting must be held and no person should be invited to address the students in the College without prior permission from the Principal.

- No student shall take private tuitions from any teacher of the College without the written permission of the Principal.
- Students applying for any certificate, testimonials, concession forms etc. and those requiring the Principal's signature on any kind of document or application, should contact the College Office at least 2 (Two) days in advance. No papers should be brought by any student directly to the Principal for signature.

5. Respect for College property:

- Students are expected to take proper care of the College property and cooperate in keeping the premises clean. Any damage to the College building or property by disfiguring walls, tables, benches, doors or breaking furniture, apparatus, fittings etc., is a breach of discipline and will be strictly dealt with imposing penalty/ suspension/dismissal.
- Smoking, chewing of tobacco, narcotics, paan and spitting is strictly prohibited in any part of the College building, including the canteen. This is a punishable offence under the Mumbai Police Act.
- Drinking and eating is strictly prohibited in classrooms.
- 6. **Mobile phones & I-Pods are restricted:** Use of mobile phones and I-Pods are strictly prohibited in the classroom. If found, the same will be confiscated and not be returned.
- 7. **Library:** It is the responsibility of the student to examine a book carefully when he/she receives it and report to the counter clerk any damage found therein. Failure to do so makes the student responsible for any damage detected later.

8. Library rules:

- The library will remain open from 8:00 am to 5:00 pm on all working days.
- Entry to the library will only be allowed using a valid ID card.
- A penalty of ₹ 5/- per day will be levied on the delay of returning/renewing the issued books.
- If the issued book(s) is/are damaged (in any manner whatsoever) or lost, the student has to either replace it or pay its full cost.
- Silence must be maintained in the library at all times.
- Reference books/journals are only for reading in the library and not for taking home.
- Students may recommend course-related book titles to their teachers to be added to the library.
- Students must turn off or keep their phones on silent mode in the library.

CODE OF CONDUCT:

The College expects every student to strictly abide by the following Code of Conduct at all times.

- 1. Identity Card (ID):
 - Students must have their identity card duly filled in and signed. Students must wear their identity card when they are in the College premises.
 - Transfer of ID cards is a criminal offence. The student will be liable to expulsion from the College for such an offence.
- 2. Littering in the classrooms, corridors and the campus is prohibited. Please use the dustbins provided all around. Offenders will be penalized.
- 3. Sitting on the vehicles in the College compound is strictly prohibited.
- 4. Loitering or crowding is also prohibited. Students are required to remain in the College campus during their free hours.
- 5. Mobile phones if carried by the students should be switched off while in classroom, library and corridors of the College. If these instructions are not followed, the instrument will be confiscated and the concerned student will also be charged a fine.
- 6. Anti-Ragging Act: Ragging is banned in the College. A student involving in any such act will be expelled from the College, not withstanding other consequences under applicable law.

ANTI-RAGGING POLICY:

The College strictly adheres to the provisions of the "Rules of Prohibiting Ragging" framed under the "Maharashtra Prohibition of Ragging Act, 1999" [Maharashtra Act No XXXIII of 1999].

This Act strictly prohibits "Ragging" within or outside any institution and imposes penalty/suspension/dismissal of any student(s) convicted under Section 4 of the Act.
